

# WV SWCS Chapter Meeting

## Teleconference

May 28, 2015

The meeting was called to order by Melissa Merritt, President at 9:05 am.

### Old Business:

#### WVU Soil Judging Endowment:

**Marcellus Shale Tour:** Melissa is still talking with Corky DeMarco- she is still getting the run around about location and date etc. Melissa has also talked with Amir Hayes about a pipeline option In Weston, WV. She has been talking with Consol Energy and they have proposed a date for July/August. Stone Energy has talked about discussing freshwater impact and they still have equipment in the field could be in many locations of the state. Still looking at the possibility of a training for July meeting/training. Suzy said she asked Jeff Skousen about reclamation of Marcellus shale sites. Nate at Neptune-Company is still a possibility too. At this point Melissa will continue to pursue the possibility with these companies and bring the information back to the group.

**Scholarships:** The scholarship applications were advertised again and 2 candidates applied. The candidate's applications were presented to the scholarship committee for selection. The chair of the committee Jeff Skousen presented the results to the group. The committee has selected applicant Bethani Chambers. She has chosen Jamey as the administrator but as the executive committee members we were encouraged to use the website to see what we liked and by the next meeting have our opinion formed in order to purchase or cancel the trial package.

Discussion was held on what Melissa and Suzy have experienced thus far. Search ability was a key for the website and membership enrollment is option along with being able to upload our reports these were a few positive feedbacks for the 1 and 1 site.

Some discussion was held on what her agency (WVCA) would pay and what we would pay as an organization. Suzy had not yet requested attending from her agency. Peg made a motion that the registration fee, awards luncheon, and the regional breakfast be paid by the organization for Suzy, as long as her agency will not pay for the costs, up to \$1,000.00. Seconded by Jamey, motion passes.
